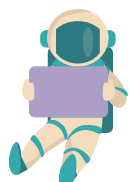

Unfold Your Potential

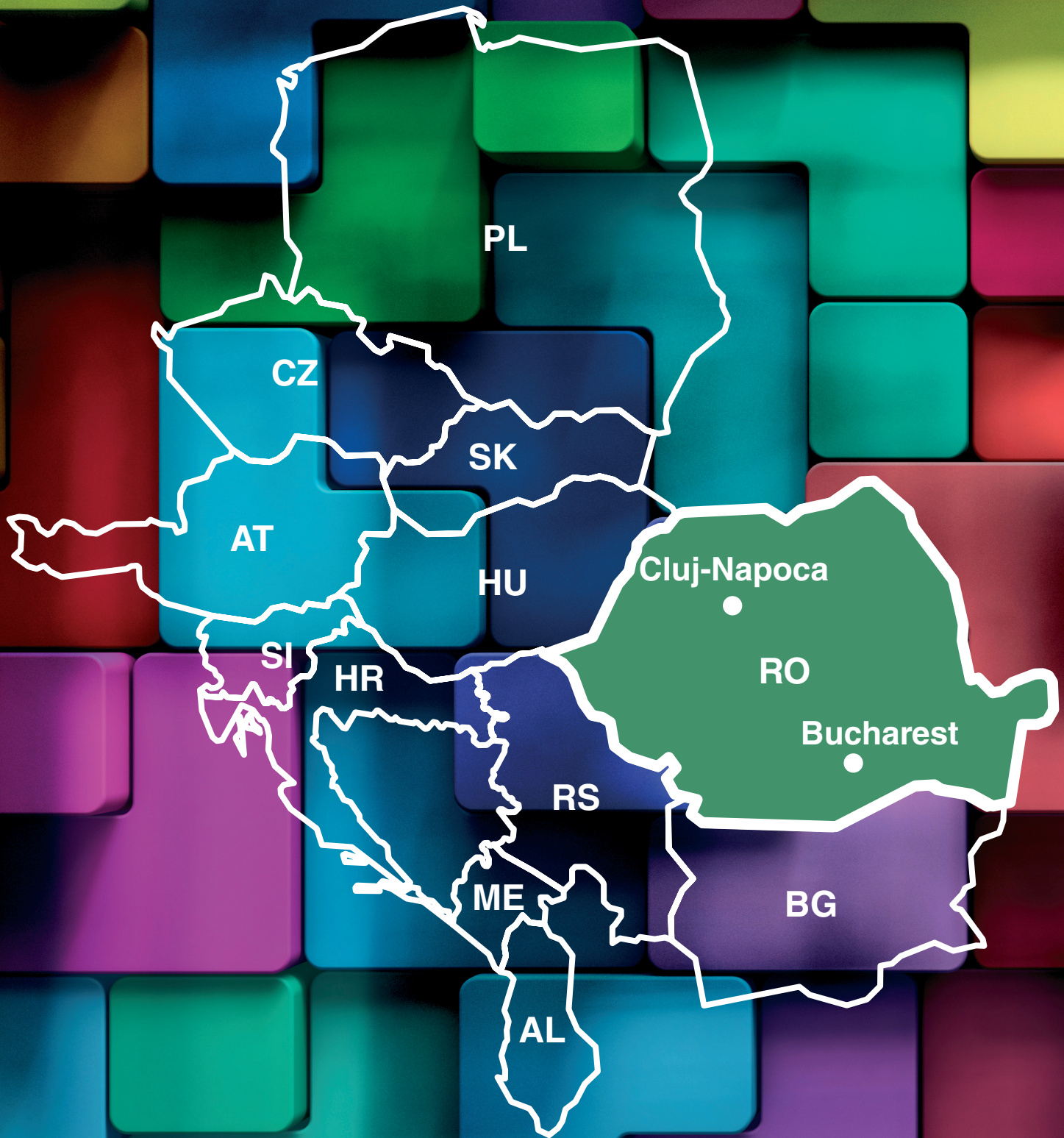
